WomenSafe provides a variety of services that strive to meet the needs of all people who experience stalking, dating, domestic or sexual violence. We define advocacy as the active support of an individual's goals by providing information and options to assist the person in making their own choices. We provide emotional support, information & referral, support groups and advocacy in the following areas through a free and confidential 24-hour hotline and in-person meetings:

- Civil & Criminal Legal
- Medical & Hospital
- Transitional & General Housing
- Systems Change

WomenSafe also provides outreach, community education, professional training, supervised visitation, and monitored exchange services.



Data Highlights

- 544 total adults and children served through advocacy and supervised visitation services.
- 7,872 in-person meetings and phone calls through the advocacy program.
- 234 supervised visits and orientation meetings for 13 families including 21 children.
- Worked with the parents/caregivers of a total of 328 children exposed to violence.
- Prevention programming reached 4,180 youth and adults through 568 presentations and outreach events.
- 63 volunteers donated 7,088 hours of services.

Highlights & Community Impact


- WomenSafe staff, Board and volunteers welcomed our new Executive Director, Elyssa Boisselle, to the team.
- Established a playhouse and library for child and parent residents of our Transitional Housing Unit. The project was made possible by the vision and generosity of a donor.
- WomenSafe staff continue to provide critical in-person services at the hospital, courthouse, or at law enforcement agencies as needed.
- WomenSafe advocacy team relaunched and reformatted support groups to better meet post-pandemic service user needs.
- In the past year, our Transitional Housing Program has successfully placed seven households, consisting of seven adults and five children, in safe and affordable housing.

Funding

WomenSafe receives funding from a combination of public and private sources and is a member agency of the United Way of Addison County. Our Mother's Day, Annual Appeal, Town Appropriation, and other endeavors consistently receive strong community support.


