




WomenSafe's Data

July 1, 2016-June 30, 2017

- WomenSafe served 468 women, children and men during 4,142 in-person meetings and phone calls.
- We worked with the relatives and caregivers of a total of 337 children affected by the violence in their lives.
- The Supervised Visitation Program completed 433 supervised visits and monitored exchanges for 28 children needing increased safety during parent-child contacts.
- The Training & Education Program reached 1,477 adults and youth with 171 presentations, professional trainings and community awareness events. Participants received information about healthy relationships, preventing child sexual abuse, sexual harassment, teen dating violence, consent and many other topics.
- Seventy-five community volunteers contributed 9,382 volunteer hours by providing services such as: staffing the 24-hour hotline, in-person office support, court accompaniment and administrative support.



Funding

WomenSafe receives funding from a combination of public and private sources and is a member agency of the United Way of Addison County. Our Mother's Day, Annual Appeal, Town Appropriation and other endeavors consistently receive strong community support.

- WomenSafe assisted Middlebury College in their response to stalking, dating and sexual violence by assisting with the training of on-campus volunteer advocates (MiddSafe).
