
Fiscal Year Ending June 30, 2019 Annual Report

July 1, 2018 – June 30, 2019 Data

- WomenSafe served 515 people during 4,800 inperson meetings and phone calls.
- We worked with the relatives and caregivers of a total of 325 children affected by the violence in their lives.
- The Supervised Visitation Program completed 213 supervised visits and monitored exchanges for 23 children needing increased safety during parentchild contacts.
- The Training & Education Program reached 2,572 adults and youth with 355 prevention workshops, presentations, and professional trainings. We also reached an additional 948 adults and youth through community outreach events. Participants received information about healthy relationships, preventing child sexual abuse, sexual harassment, teen dating violence, consent, and many other topics.
- 75 community volunteers contributed 8,691 volunteer hours by providing services such as: staffing the 24-hour hotline, in-person office support, court accompaniment, administrative support, and Board leadership.
